Reserve price: ZMW 8,800.00 net of every cost and taxes related to the transfer of property and, in case, customs duties.

Lower or "conditioned" bids will not be accepted. The winner of the vehicle will be by the bidder who offers the highest price. The vehicle will be sold on "As is, where is basis", with no warranty, expressed or implied. Buyers are solely responsible for examining and judging the vehicle for their own protection. The vehicle can be examined after calling telephone number **0211-250755** for an appointment.

The bids should be sent by registered mail to **Embassy of Italy, P.O. Box 50497, Lusaka**, or delivered by hand to the **Embassy of Italy, Plot 5211, Embassy Park, Diplomatic Triangle, Lusaka** in a sealed envelope with the notice "**Bid for Jeep Cherokee Vehicle**" written on the outside of the envelope, by 17:00hrs. on 20th April 2015.

The bidder must state the offer and in addition must include the indication of her/his address, telephone number, fax number, e-mail address and a photocopy of an identification document (Passport or N.R.C.).

Envelopes containing the bids received by registered mail or delivered by hand after 17:00hrs. on 20th April 2015 will be excluded from the bidding process.

The sealed envelopes will be opened on the 21st April 2015 at 10:00hrs.

1) The Commission appointed to the bidding of the vehicle will open, in the arranged day and hour, the sealed envelopes received within the time limit and check the required papers, for the admission to the next phase after confirming that the documents submitted are in order.

2) Thereafter, the Commission will assess the offers and declare the winner of the sale of the stated vehicle by selecting the highest bidder.

All cost relating to the transfer of property of the vehicle and, in case, customs duties will be the responsibility of the winner of the bid.

The Commission will declare the winner even if there was only one regular offer.

The Minutes of the Bidding will not have any value of contract. The contractual effects will be produced with the stipulation of the purchase agreement and the concurrent payment of the **entire cash amount of the selling price**. Therefore, the Italian Embassy in Lusaka will not take on any obligation to the winner before the stipulation of the purchase agreement.
